#### MINUTES OF THE SPECIAL MEETING OF THE LAKE MOHAVE RANCHOS FIRE DISTRICT GOVERNING BOARD

The Governing Board of the Lake Mohave Ranchos Fire District met in a special session on **Thursday 09/21/2023 at 1:00** pm. The meeting was held at **the Dolan Springs Chamber of Commerce (16154 Pierce Ferry Rd Dolan Springs, AZ).** The Board may vote to go into Executive Session on any Agenda item, pursuant to A.R.S. §38-431.03(A)(3) for legal advice and A.R.S. §38-431.03(A)(4) for legal direction with the District's Attorney on matters as set forth in the Agenda item. The following topics and any variables thereto, will be subject to Board consideration, discussion, approval, or other action. All items are set for possible action.

### 1) CALL TO ORDER

Director Koeppen called the meeting to order at 1:01 pm.

#### 2) ROLL CALL OF BOARD MEMBERS

Roll call at 1:01 pm. All five directors present.

# **Old Business:**

a. Discussion: Director Johnson opened with a quick recap of events and findings since beginning his review of existing LMRFD financial management processes and workflows. Discussion centered around understanding the existing processes, and possible refinements to improve financial process performance, particularly in the area of billing for ambulance services. Director Johnson's introduction served as a lead-in to the three new agenda items listed below under New Business.

#### **New Business:**

- a. Discussion and possible action: Assignments to vendors and employees regarding administration, reporting, collection and billing of ambulance revenue. (Director Johnson) Due to the nature of this item and its possible impacts, Director Koeppen decided to hold this item for executive session in order to obtain legal advice from LMRFD Counsel Nicholas Cornelius.
- b. Discussion and possible action: Discussion concerning the existing annual financial audit process and the advisability of retaining a forensic auditor to review District financial records and advise re: strong redundancy and security implementation for same. (Director Johnson) Due to the nature of this item and its possible impacts, Director Koeppen decided to hold this item for executive session in order to obtain legal advice from LMRFD Counsel Nicholas Cornelius.
- c. **Discussion and possible action:** Recommendation to have all existing financial/billing-related contracts with vendors, including Andres Medical and RFGI (Rozlin Financial) contract, and all future contracts reviewed by counsel prior to

signing to ensure they meet the needs of LMRFD. (Director Johnson) Due to the nature of this item and its possible impacts, Director Koeppen decided to hold this item for executive session in order to obtain legal advice from LMRFD Counsel Nicholas Cornelius.

#### **New Business:**

- **a. Discussion and possible action:** Assignments to vendors and employees regarding administration, reporting, collection, and billing of ambulance revenue. (Director Johnson)
  - Director Johnson had found a snag in reporting certain check receipts that left out billing agency blind to the fact that a payment had been made. They have been finding out for themselves by calling the insurance agencies, but the flow of information can be improved. This is one of several areas where possible improvements were identified. The board will continue working with Andres Medical to improve information flow.
- **b.** Discussion and possible action: Advisability of retaining a forensic auditor to review District financial records and advise re: strong redundancy and security implementation for same. (Director Johnson) Director Koeppen took on the task of identifying forensic auditor candidates.
- **c. Discussion and possible action:** Recommendation to have Rozlin (RFGI) contract and all future contracts reviewed by counsel prior to signing to ensure they meet the needs of LMRFD. (Director Johnson) After short discussion, the board reached consensus that all LMRFD contracts should be reviewed by legal counsel prior to signing.
